Stare Decisis Law

“Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgement and order are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.” See *Elliot v. Peirsol*, 26 U.S. 328, 340 (1828)

“A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United State Constitution Article VI, Clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.”
See *Kolovrat v. Orgeon*, 366 U.S.187, 194, 81 S.Ct. 922 (1961)

On December 22, 2023, you were duly served with process at your mailing address the Affidavit of Dispute [EXHIBIT A], along with the Affidavit of Fact: Notice of Default on December 28, 2023, and Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate– EXHIBIT: C; Memorandum of Trust dated March 20, 2021, et al. on January 4, 2024. And was given three (3) days from the date to answer and prove jurisdiction. As of this date, you have failed to answer which constitutes default. It is therefore considered;

ORDERED AND ADJUDGED that this default judgment be and the same is hereby entered against you, Richard Fairbank (hereinafter “Judgment Debtors”);

It is further ORDERED AND ADJUDGED that the Judgement Debtors are obligated to I, Santiel Marvin Raphael Chambers-Bey (hereinafter “Judgment Creditor”) for the following judgement:

- i. The immediate dismissal with prejudice of Misrepresented Instrument-Bill of Attainer / Foreign Bill of Exchange titled Loan Statement date May 1, 2023 Account Number 6201012146326 and any other attachments associated thereto for lack of jurisdiction and fraud; and the release of the following Private Property: Vehicle: 22 CHEVORLET SILVERADO 1500 VIN: [REDACTED] Account Number: 6201012146326 held at the street address of [REDACTED] Austell, Georgia [REDACTED] and geographically located at the North American continent within the dominions of the Moroccan Empire, Maghrib al Aqsá, North-West Amexem, at coordinates Latitude [REDACTED] Longitude [REDACTED] and
- ii. The total sum principal amount of \$19,704,200.00 payable in lawful money of .9999 fine silver bullion coins or bars for compensatory damages;

IT IS FURTHER ORDER AND ADJUDGED that this default judgment shall serve as a judgment lien against the oaths of office, surety bonds, and all property (real and personal; corporeal and incorporeal) and assets of the Judgement Debtors as well as their spouse, heir(s), successor(s) and assign(s), in order to secure the performance of this judgement, and to levy on such property and assets for the satisfaction of this judgement if payment cannot be made;



